All obligations must be paid prior to, or on the due date. All fees are non-refundable except as outlined in the "Club Rules, Policies, and Guidelines". EFT withdrawals are due on the 5th 10th or 20th of each month. EFT's will be assessed a \$15.00 late fee if your account processing is rejected. Delinquent members may not make changes to account, cancel or use the Club unless prior arrangements have been made. Member agrees to a \$15.00 late penalty fee if monthly payment is received more than 5 days past the due date. Should member default, member agrees to pay all costs of collection, including Collection agency fees, court costs, and reasonable attorney's fees, all of which may be paid or incurred by the holder of this note. The Club reserves the right to recovery of stolen goods and/or moneys. Your contract may come due in full. Member also agrees no other representation is made other than what is agreed to in writing herein. Failure to use facility will not relieve member of payment. You understand that Club may sell this agreement to a bank, finance company or other financial agency. Promotional company is not responsible for servicing the member.

2) I agree to abide by all the membership rules and regulations of the Club. In recognition of the possible dangers connected with any physical activity, member hereby knowingly and voluntarily waives any right of cause of action of any kind whatsoever arising as the result of such activity from which any liability may or could accrue to the Club, its officers, agents, employees or instructors.

3) Member understands they can cancel this agreement within 3-business days by sending a written notice to the Club postmarked by the third day after the date of this agreement. Once my full term is complete, if I wish to cancel my contract, I must give written notice of cancellation PRIOR to the expiration date of this agreement. If by reason of death or permanent disability, member is unable to complete their training program, their estate shall be relieved from continued obligation of making payments. Should member permanently move their residence more than 25 miles from an affiliated area, payment of this agreement will be suspended upon legitimate verification of move. Cancellation of this agreement under the proceeding circumstances will require a \$50.00 cancellation fee. If, for any reason other than the above, the contract term expires, above the cancellation, the cost of the remaining contract will be assessed. Should Club cease operations and close its doors without providing members with a like facility within a 10-mileradius, payment of this agreement will be suspended without penalty. Other than provided for in this agreement contract is non-cancelable. If you cancel with in the 3-business days, the Club will return within 15-days of the date on which you give cancellation, any payment you have made.
